During the year no record date was fixed for dividend. The Book closure dates for the year 2008 - from 25th July 2008 to 30th July 2008 & for the year 2007 - from 25th July 2007 to 30th July 2007 was considered for the purpose of purpose for declaring dividend.

During the year ended 31.3.2009, the Company has converted 14229929 warrants into 14229929 equity shares at a conversion price of Rs.95/- per share to the existing warrant holders at that point of time. Allotment of 14229929 shares was made on 10.9. 2008.

During the year ended 31.3.2009, the Company has allotted 3,00,00,000 1% fully convertible cumulative preference shares of Rs.100/- each at par to M/s Tube Investments of India Ltd (1,50,00,000 FCCPS) and M/s DBS Bank Ltd (1,50,00,000 FCCPS) on 13.3.2009 on preferential basis.
